- respect for the individual, without compromise;
- health and safety along the supply chain, so that suppliers will adopt health and safety behaviours and standards in line with this policy;
- conscious use of suitable protective equipment and periodic audit and risk assessment exercises with subsequent implementation of improvement plans.

Workplaces, installations, machinery and equipment are purchased and/or designed and maintained in good working order to ensure the protection of all workers.

The Management is committed to propagating a safety culture by promoting responsible and risk-conscious behaviour, the establishment of a corporate environment based on mutual understanding and cooperation, and allocates the necessary organisational and economic resources to ensure not only the prevention of accidents and occupational diseases, but also the ongoing improvement of health and safety conditions in the workplace.
